Engineering Terms and Special Requirements:

The lead time to provide a live working fibre connection is a minimum of 20 weeks from acceptance of our quotation. This quotation is based on the developer installing all ducting, construction of communication chambers and on site civils associated with the housing of optical network equipment for the On Site Convergence Point (OSCP).

Our quotation includes the cost of a single temporary data and/or telecommunications connection to the first site office or compound.

Our offer includes the provision of a Fibre Integrated Receiver System (FIRS). A FIRS signal survey will be performed following acceptance of the proposal to finalise the positioning of the aerials and dish. This is inclusive of an additional offer for new home owners on the development which will provide both new and existing Sky TV customers 12 months free subscription to the Original bundle on taking ownership of their new home*.

The FIRS aerials and dish will require a solid mounting within visibility of the terrestrial transmitters and satellite.
